#### Steps you can take to help keep your child safe online

Many of our children at school tell us that they communicate with their friends online using phones, iPads or games consoles. The following guidance will help you keep your child safe online.

- Have an ongoing conversation with your child. Continue to talk about the apps, games and sites they like to use, what they like and don't like and any concerns about being online. Discuss with them when to unfollow, block or report.
  - For help starting this conversation, read: <u>having a conversation with your</u> child.
- Make sure your child knows where to go for support: Remind your child they
  can always speak to you or a trusted adult if anything happens online that
  makes them feel worried or upset. Remind them that they won't be in trouble
  and that you are there to help. Click below for more information about how to

- Make sure you know who your child is communicating with online. Our children at school tell us that they as well as on phones, they often send messages through games consoles. Check regularly who your children are communicating with and set parental controls to prevent them being contacted by strangers. Make sure that your child uses devices in a supervised space in your home rather than alone in their bedrooms.

## Useful Acronyms & Vocabulary about Safeguarding

**DSL**: Designated Safeguarding Lead

PREVENT: Part of the Government's Counter Terrorism Strategy to stop people being drawn into extremism

**SPA:** Single Point of Access, a multi-agency team, managed by the Local Authority who work closely with a wide range of teams and partner agencies and facilitates different levels of support depending on the needs of children and families.

**LADO:** Local Authority
Designated Officer who deals
with 'position of trust'
safeguarding issues

**DBS:** Disclosure & Barring Service used to make safe recruitment decisions and authorise certification
