1	To consider how the Mission Statement is applied in all Curriculum, Pupil Performance and
	Standards areas and to ensure the Church's preferential option for the poor is reflected in these
	areas.
2	To receive updates on Curriculum, Pupil Performance and Standards matters and associated
	assessment procedures and provide appropriate challenge and support.
3	To ensure that the Diocese, Ofsted and parents are kept informed of Curriculum, Pupil Performance
	and Standards developments.
4	To be strategically involved in drawing up the action plan to outline intent and implication.
5	To be strategically involved in drawing up the action plan post inspection, SIP visit or other
	important visit to school and to follow up on recommendations and actions.
6	To monitor the provision of RE and Collective Worship in accordance with the Trust Deed and the
	Catholic life of the school.
7	To ensure that there is a robust response to any disruption in educational provision such as occurred
	re Covid: risk assessment, careful monitoring and melioration, including the use of technology and

	remote learning as appropriate, recovery and catch up plans and curriculum interventions.
8	To monitor the implementation and impact of a broad, balanced, progressive and enjoyable
	curriculum for each child in order to meet all National Curriculum statutory requirements, and to
	prepare them for life in the modern world.
9	To provide a curriculum that includes the teaching of British Values and anti-radicalisation.
10	To consider LA, Diocesan, DfE and CES Curriculum, Pupil Performance and Standards policies and
	proposals and recommend their adoption as and when appropriate.
11	To consider school policies in all Curriculum, Pupil Performance and Standards areas, cross
	referencing school policies with Safeguarding and Child Protection arrangements, in light of
	Keeping Children Safe in Education September 2019, and teaching children how to keep safe.
12	To annually review the School Development Plan.
13	To support and encourage staff in using a full range of assessment procedures that meet statutory
	requirements and to deliver Quality First Teaching.
14	To ensure support and to continue to facilitate the professional development of all school staff
	taking into account staff workload, staff well-being and balance.
15	To make staffing and resource recommendations in the light of Curriculum, Pupil Performance and
	Standards needs.
16	To review and update the Relationships and Sex Education Policy in accordance with government
	statutory requirements and Diocesan guidelines. {Annually}
17	To review the School's Equalties Policy and to monitor this policy in all areas of Curriculum, Pupil
	Performance and Standards. {Annually}
18	To ensure that the needs of all pupils including those with SEND, EAL and the more able are met,
	and that targets are met and exceeded.
19	To ensure that disadvantaged and vulnerable pupils make expected progress and that the gap is
	closed.
20	To make arrangements for the GB to be represented at School improvement discussions with HMI,
	Ofsted, LA and other relevant bodies and for reports to be received by the GB.
21	To oversee arrangements for individual governors to take a leading strategic role in specific areas of
	provision such as SEND, English and Maths and links to curriculum/subject areas.
22	To review the curriculum intent and impact of educational visits and school journeys (day and
	residential).
23	To ensure that the school experience is enhanced through the provision of high quality extra-
	curricular activities, including the Governors' Award, sports activities, music and Catholic Life, to
	enrich the personal growth and gospel values of each pupil.
24	To actively seek the views of pupils and parents in respect of Curriculum, Pupil Performance and
	Standards areas and to make measured improvement.
25	To receive, consider and respond to formal complaints about Curriculum, Pupil Performance and
	Standards areas, in keeping with the School Complaints Policy.

Method

- Meet termly and as necessary.
- Receive reports and policy updates on Curriculum, Pupil Performance and Standards areas in line with SDP.
- Visit the school.
- Receive all school newsletters and samples of information on Curriculum, Pupil Performance and Standards matters prepared and sent home to parents.
- Prepare information for the SEF.
- Report to the full Governing Body each term.
- Maintain current awareness of relevant legislation and policy development ensuring their application as appropriate.
- To be advised of developments in Curriculum, Pupil Performance and Standards areas from the Diocese, DfE and Ofsted, and to be kept informed of relevant school developments, by the Senior Leadership Team.
